

Land Air Sea 8100 Customer Agreement – Terms and Conditions

Please read this agreement carefully and file in a safe place. The Land Air Sea 8100 captures GPS time, position and speed for its information. However, since GPS by itself is just a receiver, a cellular data module is included to transmit the GPS information. This requires your 8100 to carry a Verizon Wireless data plan and the terms and conditions set forth within this document coincide with Verizon's data service agreement. Since the 8100 transmits data only, cellular voice and phone features referenced within the Verizon agreement are not applicable. The term of this agreement is twelve (12) months based upon the three plans available. Once the 12 months of service has been completed, your service will convert to a month to month plan. By accepting this agreement, you are bound by its conditions.

Method of Payment / Activation Fee

Customers will activate their 8100 service with a valid credit card on file. Monthly billing will be charged to the credit card on file and authorization for these charges will be considered effective upon receipt of the signed activation sheet. There is a one-time activation fee of \$ 19.95 plus advanced monthly service that will be charged once the activation sheet has been received signed. Month to month service will take place after the next 11 months of billing cycles. The activation form will be provided within the shipment.

If the customer elects not to use a credit card, prepayment of data services must be paid in advance equal to the twelve (12) month term.

Your Rights to Change or End Your Service: Termination Fees

You are agreeing to maintain service under this agreement for your minimum term of twelve (12) months. (Periods of suspension do not count towards fulfillment of the minimum term). Suspension is defined as failure of payment during any billing cycle. We will make efforts to help resolve delinquent accounts if the payment is rejected. However, Land Air Sea reserves the right to suspend service for non-payment. AN EARLY TERMINATION FEE WILL APPLY IF YOU CHOOSE TO END YOUR SERVICE BEFORE BECOMING A MONTH-TO-MONTH CUSTOMER, OR IF WE TERMINATE IT EARLY FOR GOOD CAUSE. THE EARLY TERMINATION FEE IS \$ 99 FOR PLAN A PER 8100 UNIT AND \$ 175 PER 8100 UNIT FOR PLAN B AND UNLIMITED PLANS. If you purchase this unit from an authorized Land Air Sea reseller, this agreement will still be in effect. If you elect to change your data service to a different plan within the 12 month agreement, a new agreement and term will commence at the beginning of the next billing cycle. All terminations by you during a monthly billing cycle become effective on the last day of that billing cycle. You will remain responsible for all fees and charges incurred until then and will not be entitled to any partial month credits or refunds.
